Santa Barbara School Garden with Bountiful Benefits During the Pandemic

Background

Santa Barbara County local health department (LHDs) educational project at Leonora Fillmore Elementary in Lompoc California includes direct education, indirect education and policy, systems and environmental (PSE) change support work that target the parents of school age children. The majority population at this elementary school is socioeconomically disadvantaged and includes many English language learners. The parents received direct education (pre-pandemic) using Project LEAN: Parents in Action lessons. Since receiving their education, they continued using the curriculum tools to plan and integrate additional changes at the school. The successful garden project was a direct result of using those tools and of the PSE change assistance provided by the Santa Barbara County CalFresh Healthy Living Program.

The Benefits of a School Garden during the Pandemic

Families and students from Leonora Fillmore Elementary benefited from having access to free organic vegetables grown in their school garden. The transformation of an abandoned and overgrown garden into a productive school garden was a complete success thanks to the technical assistance received from the Santa Barbara County CalFresh Healthy Living Program (SBCCFHLP), Fillmore school parent volunteers, and the school principal.



Due to the COVID-19 pandemic, the school campus was closed, but parents realized there was a very large garden that could be utilized to provide free produce to students and families during this time of need, when many were unable to work due to the pandemic. Unfortunately, the garden was in poor condition. Parents wanted to reinvigorate the once productive garden, but they were unsure of how to make this goal a reality. Using the tools from Project LEAN and the SBCCFHLP staff, approximately 20 volunteers collaborated to create

an garden reinvigoration action plan that included:

- volunteer commitment
- garden based parent education lessons provided by the SBCCFHL staff
- acquiring access to the school garden when the campus was closed
- connecting with local businesses willing to support the school garden via donations of vegetable plantings, compost, and farm supplies
- collaboration with the school's Nutrition Services Director to utilize the harvested vegetables
- collaboration with the Lompoc Food Pantry to receive produce donations from the school garden

For three months, everyone worked together to achieve a bountiful harvest of romaine lettuce, broccoli, cauliflower, tomatoes, butter lettuce, cilantro, kale, fennel, and onions. The produce was distributed as follows:

- 120 families participating in the summer lunch program
- 20 parent volunteers who worked in the garden
- Lompoc Unified School District Nutrition Services Department received over 400 pounds of produce for integration into the lunch program
- Lompoc Food Pantry Catholic Charities received over 300 pounds of produce.

Parents, school personnel and community members were very pleased with the success of the project. As a result, parents have continued cultivating the garden, parents are actively recruiting other families to participate and learn more about the school garden, local businesses committed to future donations for the garden, and the school principal is working with staff to create a student gardening club.

FNS Directive on CFHL Branded Shirts

The United States Department of Agriculture Food and Nutrition Services (FNS) denied a request from the California Department of Social Services to allow CalFresh Healthy Living state and local implementing agencies to use Supplemental Nutrition Assistance Program-Education (SNAP-Ed) funding to purchase branded shirts. Therefore, branded shirts will not be considered an allowable SNAP-Ed purchase.

However, agencies can use non-SNAP-Ed funding to purchase branded shirts for SNAP-Ed staff.

Name Tags and Aprons

FNS did specify that SNAP-Ed funds **can** be used to purchase name tags for SNAP-Ed personnel and branded aprons for educators conducting recipe demonstrations and taste tests.
