# Food is Medicine - Addressing Food Insecurity in Riverside County

#### Background

The Riverside County CalFresh Healthy Living Local Health Department – Riverside University Health System (RUHS) – utilized health screenings and a partnership with Feeding America Riverside | San Bernardino to provide food boxes to patients who self-identified as food insecure.

Feeding America Riverside | San Bernardino was awarded funding from the Food is Medicine program. Only seven food banks across the nation were awarded funding. The Food is Medicine program was originally funded by Anthem Foundation, the philanthropy work of Blue Cross Insurance Company, and since transitioning to Food Rx in 2022 this work is now funded through another source at Feeding America.

#### **Screening for Food Insecurity**

The goal of both programs is to have federally qualified health centers screen patients for food insecurity using the Hunger Vital Signs screening tool available in the Epic Electronic Health Record. The program coordinator and health center physician decided to screen all adult patients visiting the Riverside University Health System - Community Health Center

in Moreno Valley. Most healthcare facilities only screen for insecurity during pediatric health clinic visits.

The screening tool was slightly changed to ask patients if they worried about running out of food and if they worried about not having enough money to buy food within the past 30 days instead of the standard time frame of within the last 12 months. The idea is to immediately address patient needs so a food box can be given the same day of the clinic visit. This service is essential to patients that may not have access to transportation to return to the health clinic. If interested, patients are eligible to receive a food box monthly and can pick one up Monday through Friday during clinic business hours.

The health coaches and student volunteers from the University of California Riverside School of Medicine were given access to Epic and called to remind patients participating in Food Rx to pick up their food boxes each month. Any healthcare staff, including the security guard, can issue a food box to a patient at the health clinic. All staff are aware of the protocol for the food box distribution and have access to the list of patients participating in the Food Rx program.

#### **Creating New Opportunities**

After a 14 month delay due to COVID -19, November 9, 2021, marked the launch of the highly anticipated Food is Medicine program at the Riverside University Health System – Community Health Center (RUHS – CHC) in Moreno Valley.

Ten months later, the now Food Rx program has created another opportunity to expand efforts to increase access to food for low-income residents in Riverside County. CalFresh Healthy Living (RUHS), the Women, Infants and Children (WIC) Program, the Office on Aging, Feeding America Riverside | San Bernardino, and Door Dash have partnered to launch the Homebound Emergency Relief Outreach (HERO) program. WIC sites throughout Riverside County will serve as food box hubs for homebound seniors (age 60 and older) and disabled adults. Door Dash started delivering the food boxes for the HERO and Food Rx programs in November 2022.

The HERO program will allow the RUHS and the Office on Aging to partner beyond the COVID - 19 emergency response. Their combined efforts will increase outreach, especially within the eastern region of Riverside County that includes the city of Blythe, which borders Arizona. Due to the distance, servicing this area remains a challenge for many Riverside County agencies.

#### Impact

This year, 870 food boxes were distributed to patients visiting the RUHS - CHC in Moreno Valley. The food boxes are stored in a micro-mini conference room adjacent to the lobby, so patients can quickly receive their boxes in a comfortable environment.

One advantage of providing food boxes within a healthcare setting is the convenience. Patients do not have to wait in long lines outdoors at food pantries across the region. This is especially helpful since in the Inland Empire there can be extreme heat. The original plan was to have four RUHS – CHC's participate in the Food is Medicine Program, but the efforts were scaled back to a single health clinic due to the COVID - 19 response efforts in Riverside County.

The Food Rx program was at risk of losing funding and having to end the food box distribution. However, RUHS explored alternative funding sources to continue providing food boxes for patients receiving primary care at the RUHS - Community Health Center in Moreno Valley. Ultimately, RUHS successfully found an additional two years of funding through Feeding America. This will sustain the Food as Medicine intervention
